Declaration of Goods by Passengers on UK Service Flights

Who must declare

This form must be completed by passengers prior to arrival from abroad (including the Irish Republic and the Channel Islands) and then handed to the Captain for presentation to HM Customs and Excise.

If you have no goods to declare, enter 'None' in the Particulars of Goods section below.

Who must be declared and produced

Goods which are subject to a prohibition or restriction and all articles obtained abroad or during a flight or from the United Kingdom free of UK duty and/or tax, whether for yourself or for some other person, however small the quantity and whether new, worn or used. All baggage (personal and otherwise) must be declared to the Customs Officer if present; it is liable to examination and this declaration does not secure exemption from such examination. The possession or ownership of undeclared chargeable, prohibited or restricted goods will be dealt with as an attempt to smuggle.

Prohibited and Restricted goods

These include:-

Controlled drugs such as opium, heroin, morphine, cocaine, cannabis, amphetamines and lysergide (LSD).

Counterfeit currency

Firearms (including gas pistols, electric shock batons and similar weapons), component parts of firearms, ammunition and explosives (including fireworks).

Flick Knives

Horror comics; indecent or obscene books, magazines, films, video tapes and laser discs.

Animals and birds, whether live or dead (eg stuffed), and derivatives of protected species including furskins, ivory, reptile leather and goods made from them.

Meat and poultry and their products, including bacon, ham, sausages, pâté, eggs, milk, and cream.

Plants, bulbs, trees, fruit, potatoes, and other vegetables.

Radio transmitters (including CBs and walkie-talkies) capable of operating on certain frequencies, radio, microphones and microbugs.

Any prohibited or restricted goods must be brought to the attention of the person collecting this declaration.

Duty and Value Added Tax are chargeable on most articles imported
